## Fiscal Stress Monitoring System<sup>®</sup>

### Municipalities Which Have Not Filed Fiscal Years Ending 2012

The Fiscal Stress Monitoring System and resulting fiscal stress designations rely on data from annual financial reports submitted by local governments to the Office of the State Comptroller (OSC).

These lists (sorted alphabetically by class of local government) include municipalities that did not file their report as of 11/29/2013 for fiscal year ending 12/31/2012, and therefore a fiscal stress score could not be calculated.
