The Fiscal Stress Monitoring System (FSMS) and resulting fiscal stress designations rely on data from annual financial reports submitted by local governments to the Office of the State Comptroller.

This list includes municipalities for the 2018 fiscal year, updated to reflect municipalities with a December 31, 2018 fiscal year end (in bold). The municipalities noted did not file their annual financial report or reported data that was inconclusive for FSMS purposes as of the date their score was to be calculated, and therefore a fiscal stress score could not be calculated.
