In accordance with the provisions of Section 170 of the Executive Law, the following are actions that the State Education Department (Department) has taken, or will be taking, to implement the recommendations contained in the Office of the State Comptroller's (OSC) Final Audit Report (2012-S-64) of the State Education Department: Sunshine Developmental School.

<u>Recommendation 1:</u> Review the disallowances identified in this report and, considering any previous SED disallowances, adjust Sunshine Developmental's CFRs and tuition rates as appropriate.

The Department anticipates receiving information needed from OSC in order to apply the audit adjustments. We will then review and apply the recommended adjustments to the School's tuition reimbursement rates for all the findings.

<u>Recommendation 2:</u> Work with Sunshine Developmental officials to help ensure that only eligible costs are included on their CFRs.

The Department will continue to provide technical assistance and has strongly recommended that the Sunshine Developmental officials take advantage of our availability to help them better understand the standards for reimbursement as presented in Regulation and the Reimbursable Cost Manual (RCM). Furthermore, Consolidated Fiscal Report (CFR) training is available both in person, at six locations offered across the State, and online on the Department's webpage.
