Thank you for the opportunity to respond to the Office of the State Comptroller's ("OSC") Final Audit Report, "Disaster Recovery Planning," dated December 6, 2017. On behalf of the Office of Information Technology Services ("ITS"), and pursuant to Executive Law § 170, I write to provide confirmatory information concerning ITS' responses to OSC's three recommendations set forth in the Final Audit Report.

<u>OSC Recommendation 1</u>: Finalize the NYS Disaster Recovery Project: Disaster Recovery Draft Plan in accordance with ITS policies, NIST, and other relevant guidance.

<u>ITS Response</u>: ITS again reaffirms that the NYS Disaster Recovery Project: Disaster Recovery Draft Plan (the "Plan") has been finalized, and that it had been finalized prior to OSC's issuance of the Final Audit Report.

<u>OSC Recommendation 2</u>: Ensure the finalized NYS Disaster Recovery Project: Disaster Recovery Draft Plan covers ITS' own operations, including but not limited to, the centralized IT services it provides to the 46 executive agencies.

<u>ITS Response</u>: ITS again reaffirms that the Plan covers not only ITS' own operations, but also the centralized IT services it provides to the 46 executive agencies.

<u>OSC Recommendation 3</u>: Review the disaster recovery plan regularly, documenting changes needed and when those changes were made.
