Dear Comptroller DiNapoli:

In accordance with the provisions of Section 170 of the Executive Law, the State Education Department (SED) has taken, or will be taking, the following actions to implement the recommendations contained in the Office of the State Comptroller's (OSC) Final Audit Report (2024-S-19) *Charles R. Drew Early Childhood Center, Inc. (Charles R. Drew) - Compliance With the Reimbursable Cost Manual*.

Recommendation 1:

“Review the recommended disallowances identified by our audit and make the necessary adjustments to the costs reported on Charles R. Drew’s CFRs and to Charles R. Drew’s tuition reimbursement rates, as warranted.”

SED is currently reviewing the Consolidated Fiscal Report (CFR) and OSC audit work papers and will make necessary adjustments and recover any overpayments, as appropriate, by recalculating tuition rates. NYSED will further review the staffing recommendations to determine if the adjustments are appropriate.

Recommendation 2:

“Remind Charles R. Drew officials of the pertinent SED requirements that relate to the deficiencies we identified.”

SED will continue to provide technical assistance whenever requested and will strongly recommend that Charles R. Drew officials avail themselves of our assistance to help them better understand the rules for cost reporting and criteria for cost reimbursement as presented in the CFR, Regulations, and the Reimbursable Cost Manual (RCM).

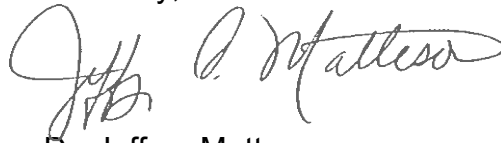
SED will alert Charles R. Drew officials of online training that is available on SED’s webpage. SED requires that all individuals signing the CFR certification statements, namely the Executive Director and Certified Public Accountant, complete this training. This training is a requirement for preschool special education providers upon approval and reapproval.

Furthermore, SED will require Charles R. Drew to identify the actions it has taken to cure and correct the deficiencies and/or violations identified in the audit. Charles R. Drew's submission to SED must:

- Be certified by its Chief Executive Officer.
- Include an attestation from each director, officer, trustee, and shareholder.
- Contain all relevant information describing how policies, procedures, and practices have been revised to address the specific findings of the audit.
- Describe the systemic changes to the internal controls and financial oversight that have been implemented.
