Pursuant to the provisions of Chapter 793 of the Laws of 1988, which amends Chapter 169 of the Executive Law, the Director of the Budget has established a new salary schedule for Officers whose salaries are contained in Section 169.

The increased salaries are effective from June 9, 1988, the first day of Payroll Period 6L. A list of the Officers and new salaries is attached. Chapter 263 of the Laws of 1987 adds the Chairman of the Workers' Compensation Board to Section 169, effective January 1, 1989. This position is now changed to other-statute (OS), salary grade 700.

The increased salaries should be reported on a PR-75 in Period 21L, the same period that the June 1988 salary increase is processed for Management/Confidential employees. Transaction code SAL INCR is used for both active and inactive employees.
