Subject April 1, 1989 Salary Increase for Employees in the Professional, Scientific and Technical Services Negotiating Unit	Bulletin No. P-608
	Date March 20, 1989

Chapter 581 of the Laws of 1988 which implements the agreement between the State and the Public Employees Federation representing employees in the Professional, Scientific and Technical Services (05) negotiating unit provides for a salary increase and a new Salary Schedule for these employees and for an increase in location pay as described below.

APRIL 1989 SALARY SCHEDULE

The legislation provides for a revised April 1, 1989 Salary Schedule. The new schedule was constructed by increasing the October 1, 1988 schedule by 5%. A copy of the revised Salary Schedule is attached.

A performance advance amount, which is one-fifth of the range of the grade, is provided for advancement within salary grade. The performance advances will continue to be paid annually, as explained in Bulletin P-582 (November 9, 1988).

LOCATION PAY

NYC, Rockland, Westchester, Nassau and Suffolk Counties

The amount of Location Pay in these areas has been increased to \$665 annually (\$25.50 biweekly) for the fiscal year beginning April 1, 1989. Location Pay is paid to all full-time employees whose principal place of employment or official station is in these areas.

Monroe County

The amount remains at \$200 (\$7.67 biweekly) for employees as previously described in Bulletin P-578 (September 14, 1988).

SALARY INCREASE

Effective April 1, 1989, employees in graded, N.S. (Grade 600) and Trainee (Grade 800) positions will receive a 5% salary increase, rounded to the next whole dollar.

The salary increase and increase in location pay are effective from the first day of Payroll Period 1L, March 30-April 12, 1989 (checks dated April 26, 1989) for Administration agencies and April 6-19, 1989 (checks dated May 4, 1989) for Institutions.

The processing of the increase is identical to the description contained in Bulletin P-606. Follow the instructions in that Bulletin for review of the tentative payroll and Exception Listing and the submission of PR-75's.
