Pursuant to the provisions of Chapter 60 of the Laws of 1993, which amends Chapter 169 of the Executive Law, the Director of the Budget has established a new salary schedule for Officers whose salaries are contained in Section 169.

The increased salaries are effective from March 25, 1993, the first day of Payroll Period 1L. A list of the Officers and new salaries is attached.

The increased salaries should be reported on a PR-75 in Period 3L, checks dated May 19, 1993. Transaction code SAL INCR is used for both active and inactive employees.
