Subject Amendment to Procedures for Processing Workers' Compensation Supplemental Program for PS&T Employees (NU 05)	Bulletin No. P-833
	Date November 2, 1994

This bulletin amends Section 1 of P-Bulletin 782, New Workers' Compensation Supplemental Program for PS&T Employees (NU-05) effective July 1, 1993, dated September 9, 1993.

Effective in Payroll Period 17L (November 10-23, 1994 for Institution agencies and November 17-30, 1994 for Administration agencies), agencies will no longer be required to submit AC-2753 Workers' Compensation Supplemental Payment Forms to initiate, change or stop supplemental payments for PS&T employees covered under the Workers' Compensation Leave with Percentage Supplement Program. Instead, these supplemental payments will be processed automatically by OSC upon receipt of statutory payment information from the State Insurance Fund. OSC will continue to use the PEF Supplemental Payment Processing Schedule (Attachments 1 & 2) to process these supplemental payments.

Agencies will continue to monitor supplemental payments by reviewing the PRG-22, Workers' Compensation Transaction Report, which is forwarded with the payroll register. This report identifies employees receiving supplemental payments under Workers' Compensation Leave with Percentage Supplement Program ('SUPP FLAG' 2) and the Award and Supplement Program ('SUPP FLAG' 1).

Agencies should continue to refer to P-Bulletin 782, Sections II through X, for other information regarding the Workers' Compensation Leave with Percentage Supplement Program.
