## Receiving LLS payment and Qualify for Equal Amount LGS payment

An employee who is currently receiving an LLS payment previously paid based on years at job rate in the amount of \$1,500 and has 12 years of qualifying service where the amount is also \$1,500, will begin receiving an LGS payment beginning the next payment cycle.

An employee who is currently receiving an LLS payment previously paid based on years at job rate in the amount of \$3,000 has 14 years of qualifying service where the LGS payment amount is \$1,500. The employee will continue to receive an LLS payment in the amount of \$3,000 until they reach 17 years of qualifying service where at that time, they begin receiving an LGS payment in an amount equal to \$3,000 beginning the next payment cycle and continue to receive a payment amount of \$3,000.

## Receiving LLS payment and Qualify for Greater Amount LGS payment

An employee who is currently receiving an LLS payment previously paid based on years at job rate in the amount of \$3,000 and has 22 years of qualifying service where the LGS payment amount is \$4,500, will begin receiving an LGS payment beginning the next payment cycle.

## Receiving LLS payment and Do Not Qualify for LGS payment

An employee who is currently receiving an LLS payment in the amount of \$1,500 and has 10 years of qualifying service will continue to receive an LLS payment in the amount of \$1,500 until they meet the 12 years of qualifying service criteria where at that time, will begin receiving an LGS payment in an amount equal to \$1,500 beginning the next payment cycle.

Since years at job rate will become obsolete as of April 1, 2025 and no longer be a factor in payment eligibility, if the employee is receiving an LLS payment based on five years at job rate and will have ten years at job rate prior to meeting the twelve years of qualifying service criteria, they continue receiving an LLS payment at the five year payment amount. The LLS payment amount will not increase to the 10-year amount once the employee attains 10 years at job rate. Once the employee meets the 12-years of qualifying service criteria, they will begin receiving an LGS payment at the 12-year payment amount.
