Subject: January 1, 1981 Salary Increase for State Officers and elimination of payments in lieu of expense

Chapter 881 of the Laws of 1980 provides for increases in salary effective January 1, 1981, for State Officers whose salaries are set in Section 169 of the Executive Law. The law also eliminates most payments made in lieu of expenses effective January 1, 1981.

The new January 1 salaries include an increase of 7% above the previous salary, rounded to the next higher one hundred dollars, and the resulting salary is further increased by the amount of any in lieu of expense payment in effect on December 31, 1980 or by one-half of that amount for the commissioner of education and the chancellor of the State University.

A list of the officers and the new salaries is attached.

The increased salaries must be reported by PR-75 in Payroll Period 21 and are payable from the first day of the period. Transaction code SAL INCR is used for this purpose.

Also, all payments in lieu of expense (either for travel or extra expenses) are eliminated effective January 1, 1981 except for those paid to the Lieutenant Governor, the Comptroller, the Attorney General and District Superintendents in the Education Department paid under section 2210 of the Education Law

PR-75's must be submitted in Payroll Period 21 to remove the in lieu of items. Transaction code REM LIEU is used for this purpose.
