Subject: January 1, 1982 Salary Increase for State Officers

Chapter 881 of the Laws of 1980 provides for increases in salary effective January 1, 1982, for State officers whose salaries are set in Section 169 of the Executive Law.

The new January 1 salaries include an increase of 7% above the previous salary, rounded to the next higher one hundred dollars. Also, Chapter 1028 of the Laws of 1981 amends the provisions of Chapter 881 to provide that the Chief of Staff to the Governor, the executive director of the State Insurance Fund and member-chairman of the Board of Parole will receive the actual salary specified in Chapter 881 for officers listed in paragraph d of sub-division 1 of Section 169 retroactive to January 1, 1981.

A list of the officers and the new salaries is attached.

The increased salaries must be reported by PR-75 in Payroll Period 21 and are payable from the first day of the period. Transaction code SAL INCR is used for this purpose.
