Chapter 986 of the Laws of 1984 provides for increases in salary for State officers whose salaries are set in Section 169 of the Executive Law effective July 1, 1984 and January 1, 1985.

A list of the officers and the new salaries is attached. The July 1, 1984 increase is payable from the first day of Payroll Period 7 Lag (June 28, 1984) and the January 1, 1985 increase is payable from the first day of Payroll Period 20 Lag (December 27, 1984).

The legislation also establishes an annual salary of \$30,000 for the Chairman of the Adirondack Park Agency effective July 1, 1984 (payable from June 28, 1984).

The increased salaries should be reported by PR-75 in Payroll Period 20 Lag. Transaction code SAL INCR is used for both active and inactive employees.
