As authorized in Section 169 of the Executive Law and Chapter 263 of the Laws of 1987, the Director of the Budget has established a new salary schedule for Officers whose salaries are contained in Section 169.

The increased salaries are effective from April 2, 1987, the first day of Payroll Period 1L. A list of the Officers and new salaries is attached. Chapter 263 also eliminates the Chairman of the Workers' Compensation Board from Section 169. This position is now changed to non-statutory (NS), salary grade 600.

The increased salaries should be reported on a PR-75 as soon as possible. Transaction code SAL INCR is used for both active and inactive employees.
