This bulletin contains instructions for processing payroll deductions for Federated Community Campaigns for deductions to begin in January, 1989.

"Pledge and Payroll Deduction for Federated Fund Contribution-SEFA Cards" will be distributed with the campaign literature for the SEFA Campaign. Instructions for completing these cards can be obtained by contacting OGS Counsel's Office at (518) 474-5607 if you have not already received them. Employees who wish to contribute through the payroll deduction plan must complete a card.

Each payroll office must review the authorization cards, before they are submitted to this office, for completeness, accuracy and legibility of the items listed below. Only the original card should be forwarded to OSC. The copy and the receipt must be returned to the campaign.

- 1. Federated Fund Code

  The federated fund must be one that has been approved by the Commissioner of General Services. Alphabetic and numeric lists of organizations approved by the Commissioner follow this bulletin. If the code is not on the card, return it to the employee for completion.
- 2. Amount of deduction The employee is to enter the amount of gross salary he or she wishes to have deducted from <u>each salary check</u> for the calendar year, not the total amount of the pledge.
- 3. Signature
- 4. Employee's agency code, line number, social security number and name\*. This information should be reported as you expect it to appear on your final payroll of 1988. However, the cards should be submitted by the dates on page 2 of this bulletin.

\*Name should be printed.

Except for employees who wish to start or change a federated fund deduction after the campaign has ended, payroll deduction Form AC-1040 is not needed. The cards have been designed to provide the Office of the State Comptroller with all the information necessary to start deductions beginning with the first payroll paid in January 1989, with no further action required on the part of the payroll agency, as long as the cards are received in OSC by the required dates. Agencies which do not submit the cards on time must submit AC-1040's for the first payroll period of 1989, and forward the deduction authorization card to the Office of the State Comptroller with a notation that an AC-1040 has been submitted.

The original copy of the completed authorization cards should be received no later than the following dates:

Administration: November 25, 1988 Institution: December 2, 1988

#### DEDUCTION CHANGES

New employees or employees who wish to start or change a federated fund deduction after the campaign has ended, including during the contribution year, may do so by completing a new authorization card. Payroll Deduction Form AC-1040, should be completed by the payroll office, entering in Section 7, "Other", the following information:

- 1. The appropriate three-digit federated fund code in a "Code" Block.
- 2. The amount to be deducted from each salary check in the corresponding block.

Submit Form AC-1040 with all other AC-1040 forms for the payroll period in which the deduction is to take effect. Forward the original copy of the deduction authorization card to the Office of the State Comptroller, Bureau of Payroll Audit, Deduction Section, with a notation that an AC-1040 has been submitted.

#### TRANSFERS

Since it can not be assumed employees transferring to another N.Y.S. Agency wish to continue contributing to the same SEFA organization, we can not automatically transfer this deduction. Payroll Officers should, however, contact employees transferring into their agency to determine if the employee wishes to continue SEFA deductions. If the employee wishes to continue the deduction, an AC-1040 must be submitted to start the deduction in the new agency. It is only necessary to obtain a new authorization card if the employee wants to contribute to a different SEFA organization from the one they were contributing to in the previous agency. New authorization cards must be forwarded to OSC.

#### CANCELLATIONS

When an employee wishes to cancel the authorization for payroll deduction, notice must be submitted to the payroll office. The payroll office should prepare a Payroll Deduction Form AC-1040 entering in Section 7, "Other" the following information:

- 1. Insert the appropriate three-digit code in a "Code" Block.
- 2. Insert 0.00 in the corresponding block.

Submit Form AC-1040 with all other AC-1040 forms for the payroll period. Submit the employee's cancellation notice to the Office of the State Comptroller. Bureau of Payroll Audit, Deduction Section, with notation that an AC-1040 has been submitted.
